

Dating Q & A with Dr. Melissa Brown By: Out of Sync Woman

Q: I'm really nervous about dating, especially approaching someone for the first time. I have a hard time reading other people's body language. Do other people not on the Autism Spectrum have similar experiences?

A: Absolutely. Most people are quite nervous to introduce themselves to someone they are interested in. It is a natural human need to want to fit in and not fail. Most people are afraid of failing so they never really try. And to be honest if we never try, we will never succeed. There will be times if we do approach someone, it does not work out well and then there will be times of success. So, it never hurts to introduce yourself and offer a compliment to someone whom you might want to get to know. Q: Dr. Brown, are there any viewing recommendations that you would suggest for the body language of flirting?

A: I do not have any specific recommendations but books or movies about body language are very helpful. There are many movies in pop culture which demonstrate healthy and unhealthy ways to flirt. It is always important if you are unsure of a behavior to seek out the support of a trusted person and run it by that individual.

Continuing Legal Education credits will be available.




Health Care Quality Units (HCQU)
